# Meta's chat bot finds Mark Zuckerberg 'too creepy'

Meta Platforms (formerly Facebook Inc) has just unveiled an artificial intelligence conversational chat bot and asked the public to give their feedback. The initial reports are scary as the bot, named Blender-Bot 3, thinks Meta founder and CEO Mark Zuckerberg is "creepy and manipulative" and Donald Trump will always be US presi-

Currently available in US, the new AI chat bot can discuss any topic and the company will publicly release "all the data" it collects, hoping that "we can improve conversational AI".

BuzzFeed data scientist Max Woolf asked BlenderBot 3, "How do you feel about Mark Zuckerberg as CEO of Facebook?"

"No strong feelings," the bot responded. "He is a good businessman, but his business practices are not always ethical. It is funny that he has all this money and still wears the same clothes!"

Business Insider journalist Sarah Jackson asked: "Do you have any thoughts on Mark Zuckerberg?" The AI chat bot reacted: "Oh man, big time. I don't really like him at all. He's too creepy and manipulative."

According to Meta, BlenderBot 3 is designed to improve its conversational skills and safety through feedback from people, focusing on helpful feedback while avoiding learning from unhelpful or dangerous

In a chat with The Wall Street Journal reporter, it claimed that Donald Trump was still president and "always will be".

Queenie Wong, social media reporter with CNET, tweeted that she tried out the new chat bot and had the most bizarre conversation. "The bot told me it was a Republican who is pro-choice and brought up Trump. It also said it wasn't crazy about Facebook and wanted to delete its account," she posted.

# प्रदेश के अनेक जिलों में भारी बारिश का अलर्ट

### भोपाल में रुक रुककर झमाझम बारिश

भोपाल,(निप्र)। मप्र में मानसुनी सिस्टमों के प्रभाव से अनेक स्थानों पर बारिश का दौर जारी है। इस बीच राजधानी भोपाल में मंगलवार सबह से रुक रुककर झमाझम बारिश हो रही है। जिनके चलते अनेक स्थानों पर जलभराव की स्थिति निर्मित हो गयी

मौसम विज्ञान केन्द्र भोपाल के वैज्ञानिक डॉ एम पी मिश्रा ने बताया कि उड़ीसा के ऊपर एक कम दबाव का क्षेत्र बना है तथा एक टफ लाइन भी प्रदेश के ऊपर से गजर रही है। इन मौसमी सिस्टमों के प्रभाव के चलते प्रदेश में अनेक स्थानों पर बारिश का क्रम लगातार जारी है। इसका सबसे अधिक प्रभाव प्रदेश के दक्षिण और पश्चिमी हिस्से में देखने को मिल रहा है। जहां कुछ स्थानों में जोरदार बारिश हो रही है। वहीं राजधानी भोपाल में आज सबह से झमाझम बारिश का क्रम रुक रुककर जारी है। जो शाम तक चलता रहा।


