The above financial results for the quarter ended 31st December, 2025 were reviewed by the Audit Committee and approved by the Board of Directors at their respective meeting held on 10th February, 2025, in terms of regulation 33 of SEBI (Listing Obligation &amp; Disclosure Requirements) Regulations, 2015.

2. In the Statement of Standalone Unaudited Financial Results for the nine months ended 31st December 2025, the "Other Income" includes the notional income of Rs. 114.85 Lakhs (Nine Months Ended 31.12.2024: Rs. 91.47 Lakhs) on account of investments being valued at fair value through profit and loss account (FVTPL) in accordance with the provisions of Ind AS. Further, other income includes Rs. 265.00 Lakhs net (Nine Months Ended 31.12.2024: Rs. 43.77 Lakhs) income on account of sale of long term investments.

3. The Government of India has notified the implementation of four new Labour Codes on 21st November, 2025, by consolidating and rationalizing 29 existing labour laws. The Company has estimated the financial implications thereof and has made additional provision of INR 9.60 Lakhs in the financial results for the quarter and nine months ended on 31st December, 2025.

4.
